#### **Excavation Terms:**

All materials are guaranteed to be as specified above. All work will be completed in a professional and workmanlike manner according to standard practices and building codes. Any alteration or deviation from the above proposal involving extra costs such as encountering rock, ground water or unsuitable backfill material will be executed only upon a written change order and will become an extra charge over and above the proposal. All export is solely based on the engineered plans and contours. Any export beyond the estimated quantity will be billed at \$450 per load. In the event that we don't have enough room to stockpile dirt onsite for backfill, it will need to be stockpiled at an offsite location at \$450 per load and imported back to the jobsite at \$450 per load. This proposal does not include any snow removal services. All scheduling is contingent upon strikes, weather, accidents, or unforeseen delays beyond our control. Bid is broken down by trades for convenience, but price per trade could/will change if scope changes.

## Bid Exclusions:

Sewer does not include any e-one valve or pump installation, if needed, this is assumed to be done by plumber.

Permits, fees, bonds and unforeseen items.

This bid is based on existing material being suitable for backfill, does not include any dewatering.

Any import other than described above.

Survey, testing, and quality control

Topsoil.

Any rock excavation If rock is encountered \$250 per hour will be charged.

Winter conditions.

Does not acknowledge a soils report.

Any landscape work, revegetation, or soil stabilization other than described.

During time of any trenching excavation on existing landscaping with sprinkler systems it is inherent that sprinkler systems and landscaping will be damaged. Any repairs will be repaired at a Time and material rate and this is NOT included in any bid unless specifically stated in bid.



#### **Contractor Terms:**

Contractor agrees to perform the services described in this contract. Any services not specifically described in this contract or subsequent addendum(s) shall be considered additional services, and shall be priced separately by Contractor. Any changes or additional work shall be paid for or arrangements will be made before additional work begins. If no change order is signed then work will be performed on a time and materials basis.

#### Estimate:

Contractor will make reasonable efforts to accurately estimate the materials needed to complete the Contract. However, Customer acknowledges that there may be differences between the estimate and the final price. If the actual price is less than the estimated Contract Price, that amount will be discounted on the final payment due. If the actual price is more than the estimated Contract Price, that additional amount will be added to the final payment due. Customer agrees to pay the amount due.

## **Completion Date:**

Estimates regarding of the number of days to complete the contracted work and an expected start date are provided as a courtesy. Delays resulting from inclement weather, strikes, labor disputes, material shortages, licensing or regulatory agency inspections, or any other actions or causes beyond Contractor's reasonable control do not after or invalidate any part of this Contract.

#### Termination:

Customer may cancel this contract by providing five (5) days advance written notice. Contractor will retain any monies paid by Customer up to the effective date of termination, and is entitled to any expenses for materials or other expenses incurred by Contractor.

### Marketing:

Contractor reserves the right to photograph clients properly and use any photos for marketing purposes. From time to time contractor may stop by and take additional progress photos of clients property. Contractor will contact client and schedule a time to take photos or if contractor has a need to bring another potential client by the property. Any work performed by Exact Excavation LLC or their subcontractors can not be photographed, video taped or documented in any way or used by any other subcontractors without prior written permission.

## Damage & Insurance:

Contractor shall not be liable for personal injury to any person on Client's property or damage to Client's property, including, but not limited to, curbs, driveways, walks, lawn, landscaped areas, and patios unless such injury or damage is caused solely by the gross negligence of Contractor. Contractor shall maintain worker's compensation insurance and liability insurance for personal injury or property damage caused solely by Contractor's gross negligence. Since large machinery is used during our work, it may be possible to damage concrete or sprinkler systems. During time of any trenching excavation on existing landscaping with sprinkler systems it is inherent that sprinkler systems and landscaping will be damaged. Any repairs will be repaired at a Time and material rate and this is NOT included in any bid unless specifically stated in bid. Concrete will be replaced only if it is damaged beyond repair. This does not include cracking as it is an inherent characteristic of concrete and is often unavoidable. Contractor shall not be liable for any damage to sewer risers, sewer lines,

## Warranty:

Contractor hereby agrees to warranty any workmanship, material and labor for a period of 12 months after installation. Defects due to negligence of workmanship or defects in materials used shall be repaired by contractor, if deemed by a reasonable third party as necessary. Contractor's warranty extends solely to work performed within the scope of the original contract or any written addendum thereto.
